The user's Windows XP Professional client computer can connect to all Windows-based network resources by name and by IP address. Other users report the same problem connecting to Server7. You need to ensure that all computers can connect to Server7 by name. What should you do?**

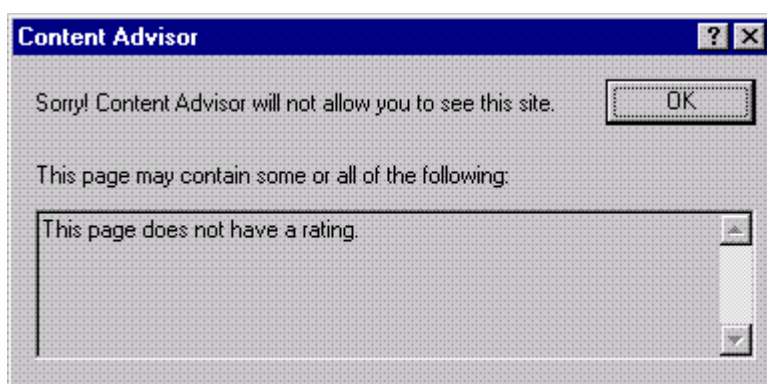
